Mayor Rogers called the meeting to order at 6:00 pm, followed by the Pledge to the Flag.

### **WORKSHOP WITH GUEST:**

Mayor Rogers and the Board, Clerk-Treasurer Carmel, and Clerk Jeary had a lengthy discussion with guest, Laura Landers, CPA, regarding village finances and the 2025-26 Budget.

### **OLD BUSINESS:**

WWTF: Phase 3, General Contractor: **Trustee Yacuzzo made a motion for a Resolution to Approve Pay App #2 in the amount of \$519,650.00 for STC Construction Inc.** It was seconded by Trustee Bonacquisti, and passed with voting as follows: Trustee Yacuzzo – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Aye.

### **NEW BUSINESS:**

Resignation of PT Police Officer: Chief Kellogg said that Officer Brown, who had done a great job as a part-time School Resource Officer, had accepted a full-time position with Medina Police Dept. **Trustee Bonacquisti made a motion for a Resolution to Accept Officer Brandon Brown's letter of Resignation, effective 2/24/2025.** It was seconded by Trustee Kettle, and passed with voting as follows: Trustee Yacuzzo – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Aye.

#### ADDED:

On Chief Kellogg's recommendation, Mayor Rogers appointed Nicholas Clarke as a part-time Police Officer. **Trustee Bonacquisti made a motion to Ratify the Appointment of Nicholas Clarke to the position of PT Police Officer at \$15.38/hour.** It was seconded by Trustee Kettle, and passed with voting as follows: Trustee Yacuzzo – Aye, Trustee Kettle – Aye, Trustee Bonacquisti – Aye, and Mayor Rogers – Aye.
