Mayor Rogers called for a moment of silence in recognition of the passing of former LeRoy Mayor Sid Horgan and of former Trustee Dick O'Shea.

Mayor Rogers called the meeting to order at 7:02 pm, followed by the Pledge to the Flag.

APPROVAL OF MINUTES: Trustee Bonacquisti made a Motion to Approve the Minutes of the Board of **Trustees Regular Meeting on 7/16/2025.** It was seconded by Trustee Tetrault and passed unanimously.

DEPARTMENT CONSIDERATIONS:

LPD:

- The Police Dept has received many complaints regarding ebikes and speeding cars with loud exhausts. This week, parents of the individuals involved were contacted and all except two have heeded the police request. The issue of ebikes is challenging as laws haven't caught up to technology. Ebikes don't require a license, registration, signals, or insurance.
- The LPD and DPW are working on getting signage put up at the four Village entrances regarding jake brakes.
- LeRoy requested installation of flashing school zone signs on State Route 5. NYS Dept. of Transportation reviewed the school speed limit on Route 5, including crash history analysis and a site visit. The resulting recommendations include increasing some sign sizes and relocating other signs.

STP & DPW:

- Mayor Rogers said that the DPW is currently adding metal siding to some of the STP outbuildings.
- Trustee Yacuzzo stated he met Supt. Carroll and Michelle Vincent, NYS DEC Engineer, at the Sewage Treatment Plant. He said the lab was in better maintenance shape. She was concerned about the dry Oatka Creek bed. He said that in the 1980s the Village proved, and it's in DEC records, that the creek is in continuous flow. It goes underground.

ADDED:

Trustee Yacuzzo asked the Board for permission to draw up an architectural improvement award to property owners that make a significant improvement, architecturally, to their properties. The Board gave permission, and the suggestion was made to call it the "Tom Spadaro Award."

RESOLUTION AUTHORIZING AN EXPENDITURE FROM POLICE EQUIPMENT RESERVE

WHEREAS, pursuant to General Municipal Law section 6-c, the LeRoy Village Board of Trustees established a Police Equipment Reserve for the acquisition of equipment for the LeRoy Police Department; and WHEREAS, the LeRoy Village Board has authorized the transfer of proceeds from the sale of surplus LeRoy Police Department equipment to the Police Equipment Reserve; and

WHEREAS, the LeRoy Police Department has determined the need to purchase police vehicles and negotiated with GSA Fleet Sales for a price of \$4,500.00 to purchase a 2017 Ford Ford PIU and \$4,500.00 to purchase a 2018 Dodge Charger; and

WHEREAS, the A895 Police Equipment Reserve has adequate funds to the cost of said purchase; and NOW THEREFORE, BE IT RESOLVED, the LeRoy Village Board hereby authorizes the expenditure from the A895 Police Equipment Reserve for the LeRoy Police Department to purchase a 2017 Ford Ford PIU, VIN: 1FM5K8AR5HGB72437, in the amount of \$4,500.00 and a 2018 Dodge Charger, VIN: 2C3CDXKT9JH181103, in the amount of \$4,500.00, from GSA Fleet Sales for a total of \$9,000.00.

OFFICIAL CONSIDERATIONS:

<u>Trustee Bonacquisti</u>: He said he was looking at the news about neighboring towns and the selling of land for solar. He believes "the farmers are selling their souls."

<u>Trustee Kettle</u>: He wished to thank Sid Horgan and Dick O'Shea for their years of service to the Village of LeRoy and condolences to their families.

<u>Trustee Tetrault</u>: A post on Facebook recently showed one of the street signs for Bradnell Ave was misspelled. He'd known it was misspelled, it was a fairly new sign, but it was corrected not long after the post.

<u>Trustee Yacuzzo</u>: He's on the Consolidation Plan committee and wanted the Board to know that when it comes time, they will be presented with the plan the committee put together. The Board will need to read through it, discuss it, make amendments to it, and then adopt it. He also asked about lighting the falls and the Board would like to do it, before Christmas.

Mayor Rogers: He'd like to see a Christmas tree at the Wiss Corner. The ground, unfortunately, is not particularly stable as it has fill from when the Wiss building came down. They're considering putting small trees up, ziptied to stakes. About the passing of Sid Horgan and Dick O'Shea, he said it was a pleasure to serve with two guys who had LeRoy in their hearts. You could never question their passion and love for the community of LeRoy.

- He spoke to LeRoy Rotary recently, and gave them a SWOT analysis of the state of the Village:
 - o Strength the Village is in a good position financially
 - Weakness the ages of the Board and some employees are nearing or over retirement age
 - Opportunity he believes the Village growth will be in residential family homes
 - o Threat inflation has caused and will continue to cause cost increases
